DEREGULATION ON AGENDA AS AJIT PAI CHAIRS FCC

Last week, the appointment of Commissioner Ajit Pai as Chairman of the FCC became official. Since his appointment on January 23, he has released a list of acting bureau chiefs at the FCC (here), including naming Michelle Carey, a long-time FCC employee, as Acting Chief of the Media Bureau upon the departure of Bill Lake who held that position through Chairman Wheeler's administration. Chairman Pai also addressed the Commission staff, among other things talking



about how much he loves working at the FCC and how important the staff is in accomplishing changes in regulations at the Commission (the speech is available here).

What can broadcasters expect from Chairman Pai? In the past, Commissioner Pai has been a big advocate of AM improvement, even moderating panels at NAB and other conventions to discuss ways to resolve AM issues. He also has spoken out against restrictive ownership rules (a review of which are likely to be on the agenda shortly, see our articles here and here), and against many of the nitty-gritty regulations that broadcasters face - most recently about the noncommercial ownership reporting rules for Biennial Ownership Reports (see our post here). So we are likely in for a deregulatory ride - how far and how fast remain to be seen.

NEXSTAR BUYS OUT MEDIA GENERAL

Almost a year after announcing the proposed deal, Texas-based Nexstar completed its purchase of Media General, a \$4.6 billion cash and stock transaction.



Nexstar, now known as Nexstar Media Group, added 71 Media General television stations to its roster as a result of the

merger. Nexstar had to sell off 13 stations to win federal approval, which brought in \$548 million for the company.

With 171 stations, Nexstar is now the second-largest independent owner of TV stations in the U.S. Their holdings include WFFF (Local 44) in Colchester along with sister station WVNY-TV (Local 22).

CEO Perry Sook says his stations will continue to emphasize local news coverage. "Our increased scale will allow us to create news bureaus in more state capitals than any other broadcaster, and Nexstar Media Group will produce over 3,500 hours a week of local news for medium and small markets while employing almost 10,000 people," Sook said.

NYC RADIO LEGEND DIES IN BENNINGTON



Herb Oscar Anderson

Herb Oscar Anderson, morning man at WABC in the 1960's, passed away January 29 at Southwestern Vermont Health Center in Bennington. Anderson was 88. He had been living on a farm in Hoosick Falls. New York when a

medical condition worsened.

From 1960 to 1968, he was the original "Morning Mayor" of New York radio, and was an original member of WABC's "Swingin' Seven" lineup that included Scott Muni, Don McNeil and others. His low-key, folksy style helped WABC's Top 40 rock and roll format become popular among adults, not just teenagers. He'd start each show singing "Hello Again," an easy listening melody.

He left WABC in 1968, saying the harder edge of the latest rock records didn't match his mellow style. He returned to New York in the 1970's on WHN, and also worked at WMCA, WBBM and WMGM, among many others. Until recently, he had been hosting a weekly show on WOSN in Vero Beach, Florida.
