We, the subscribers, of full age, hereby associate ourselves

together as a corporation under the laws of the State of Vermont,

to be known by the name of Vermont Association of Radio and

Television Broadcasters, Inc., and its principal office shall be

located in Newport, in the county of Orleans, State of Vermont.

The objects and purposes of this corporation are as

follows:

To promote cooperation and understanding among its

members; to foster and promote the development of the

art of broadcasting; to encourage and promote customs

and practices which will be for the best interest of the

public and the broadcasting industry; to protect its

members in every lawful and proper manner from injuries

and unjust exactions, and to act as a regional contact

with the National Association of Broadcasters.

In general, to carry on any operation or activity in

connection with the foregoing objects and purposes and

to have and exercise all the powers conferred by the

laws of Vermont upon associations formed under the laws

of such State, and to do any and all things herebefore

set forth to the same extent as natural persons might

or could do.

Membership in this Association shall be limited to

licensed broadcast stations or broadcast networks in

the State of Vermont. Wherever a member is other than

a natural person, it shall select a representative

actively engaged in the business of such member and shall

file the name of such person with the Secretary-Treasurer,

and such representative may represent, act for and vote

for the member.

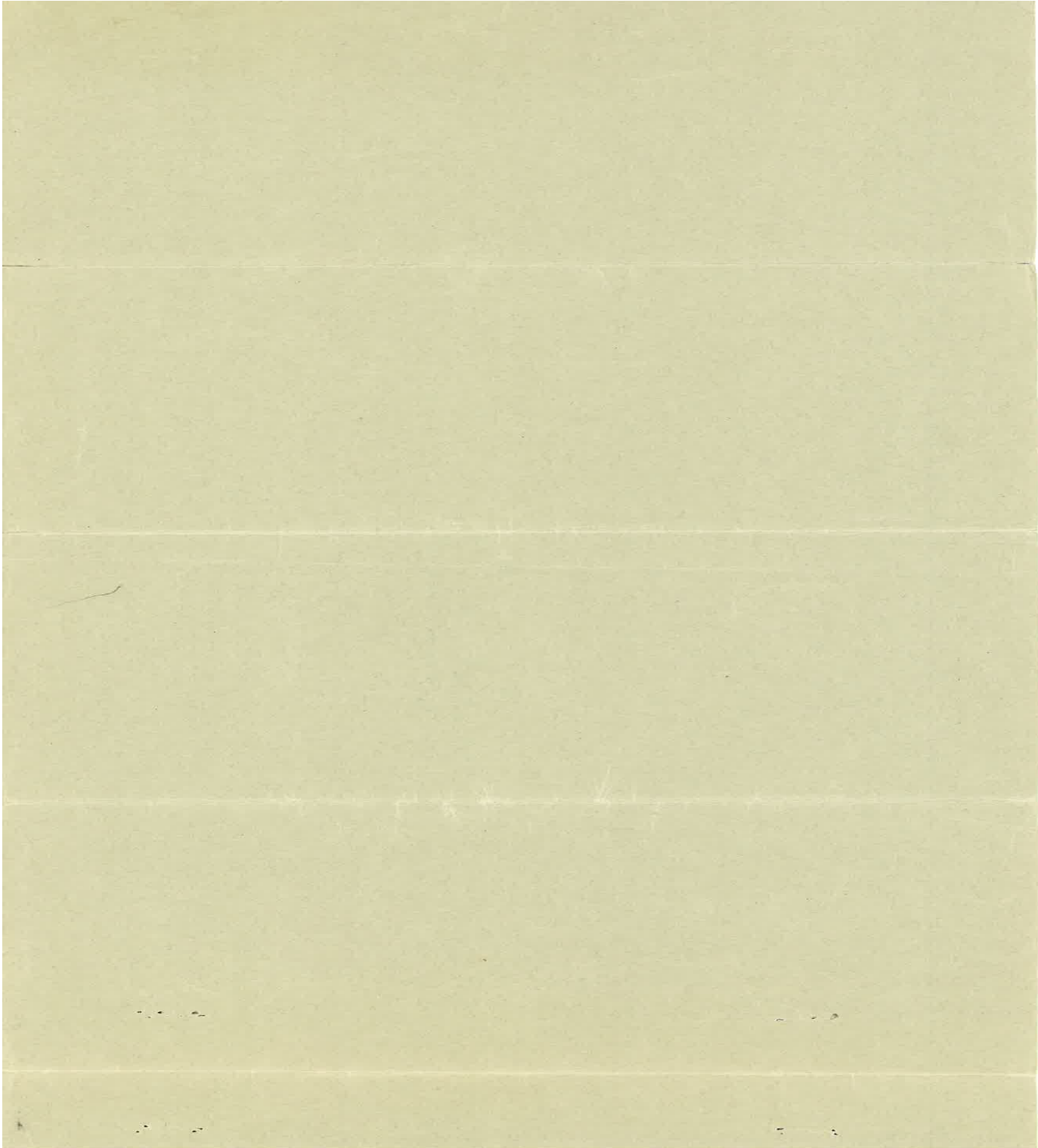
